Sub: Disclosure under Regulation 30(4) of SEBI (LODR) Regulations,2015 Notice of two days nationwide Bank Strike on 30th &31st January, 2023 given by United Forum of Bank Unions (UFBU)

Pursuant to Regulation 30 read with Para B(6) of Part A of Schedule III and other applicable provisions of SEBI (LODR) Regulations,2015, we inform that, we have been advised by the Indian Banks' Association (IBA) that United Forum of Bank Unions (UFBU) has served a Notice of Strike, informing that the members of the constituent Unions of UFBU viz.AIBEA, AIBOC, NCBE,BEFI,INBEF and NOBW) and other 4 Officers' Associations (AIBOC, AIBOA, INBOC and NOBO) propose to go on a nationwide Bank Strike on 30th & 31st January, 2023 in support of their demands.

We advise that while the Bank has made necessary arrangements to ensure normal functioning in its branches and offices on the days of Strike, it is likely that work in our Bank may be impacted by the Strike, in the event of the Strike taking place.

In terms of SEBI Circular NO.: CIR/CFD/CMD/4/2015 dated 09.09.2015, we advise as under:

- 6.1. At the time of occurrence
 - a) expected quantum of loss/damage caused;
 - b) whether loss/damage covered by insurance or not including amount;
 - c) estimated impact on the operations in case of strikes/lock outs.
 - d) unit where the strike takes place including reasons for such strike.

Loss/damage if any, can not be quantified now

- 6.2. Regularly, till complete normalcy is restored:
 - a) Insurance amount claimed and realized by the listed entity for the loss/damage;
 - b) The actual amount of damage caused due to the natural calamity or other force majeure events;



c) Details of steps taken to restore normalcy and the impact of the natural calamity/other force majeure events on production of service, financials of the entity.
