## DETAIL TERMS AND CONDITIONS FOR APPOINTMENT AS COUNSELOR OF FLC AT CHANDIGARH ZONE

For engagement of retired bank officials as in charge to oversee overall functioning of FLCs, the following terms and conditions to be read and followed by the applicant for appointment as counsellor of FLCs.

- 1) The applicant should have retired on attaining superannuation from Bank's service as minimum officer in scale II and above as in charge for FLC will be on contractual basis.
- 2) Candidate should be resident of local area.
- 3) His integrity should not have been doubtful during his service in the bank.
- 4) Counsellors are expected to counsel the public in all issues related with financial institution, proficiency in local language (reading, writing, speaking & understanding) is essential.
- 5) The monthly consolidated remuneration is Rs. 18,000/- per month subject to conduct of minimum 8 outdoor camps per month. An additional sum Rs.500/- to be paid towards telephone expenses on declaration basis. As these counsellors are expected to conduct outdoor camps as well, a lump sum expenses of Rs. 1500/- be reimbursed in lieu of not providing conveyance, providing they are holding minimum 8 (Eight) such outdoor camps per month.
- 6) Working days-6 days per week (Except notified holiday as per NI Act).
- 7) An official should have right aptitude/flair for training and rural development activities and needs special skill.
- 8) The age should not be above 65 years with sound health.
- 9) Qualification-Graduate/Post Graduate degree from a UGC recognized University.
- 10) The applicant should possess satisfactory service certificate from the previous employer.
- 11) The applicant should be well conversant with the local language.
- 12) Application should be sub titles in banks prescribed format along with employer certificate.
- 13) The selection is based on performance in the interview. Decision of the bank's in this regard will be final.
- 14) The candidate will be engaged on contractual basis for period of one year. Renewal may be possible at banks sole discretion in terms of extant policies and rules.
- 15) The contract may be terminated by either side by giving one months notice.
- 16) Date of interview will be decided with due consultation with higher authorities and sommittee for the same.
