<u>Detailed Terms and Conditions for Engagement of Watchman cum Gardener for RSETI Unnao</u>

For engagement of Watchman cum Gardener (on contractual basis for a period of 3 years) the following terms and conditions to be read and followed by the Applicant:

Job Profile of RSETI Watchman cum Gardener:

- 1. Watch and ward of the premises.
- 2. Gardening work and maintenance and upkeep of the premises.
- 3. In case of need, to perform the duties of the attendant.
- 4. Any other work entrusted by the Director RSETI from time to time.

Eligibility:

- i) The candidate should have passed 7th Standard.
- ii) Candidate with the ability to read and write local language will be preferred.
- iii) The candidate should have experience preferably in agriculture/ gardening/ horticulture.
- iv) The candidate should preferably be a resident of the district where the RSETI is located.

How to apply:

The application should be submitted by the candidate with necessary documents as per Bank's prescribed format (Annexure-II) which is available from our Bank's official website.

Age Criteria:

Minimum 22 years and maximum 40 years subject to physical fitness.

Selection Procedure:

The selection of the candidate is based on performance in personal interview. Decision of the Bank in this regard shall be final.

Remuneration:

The remuneration will be **Rs. 12,000/- (Rupees Twelve Thousand only)** per month on contractual basis.
