Provision for further renewal subject to satisfactory performance, conduct / behavior at Bank's sole discretion in terms of extant policies and rules. The contract may be terminated by either side by giving one month's notice. The following terms and conditions to be read and followed by the applicant.

Eligibility:

- Should be a graduate/postgraduate preference will be given MSW/MA in Sociology/ Psychology/ B.Sc. (Veterinary), B.Sc. (Horticulture), B.Sc. (Agri.), B.Sc. (Agri. Marketing)/ B.A., etc.
- Should have a flair for teaching and possess sound computer knowledge.
- Excellent communication skills in the local language and essential fluency in Hindi and English would be an added qualification.
- Should be proficient in MS Office (Word, Excel, PowerPoint)
- The candidate should be a permanent resident of the district where the RSETI is located.

Experience Desirable:

- 2 years in-house Faculty or visiting faculty with supporting documents like experience certificate/trainer certificate.
