1. GENERAL

This is with reference to Bank's empanelment of vendors for supply, installation, Commissioning & Maintenance of Security Gadgets done for the period from 01-07-2023 till 30-06-2026 vide our **Tender Ref No. 2202-0952023 dated 09-05-2023**. While the empanelment of System Integrators (SIs) was done for Three (3) years, the security gadgets and their rates were fixed for one year to be reviewed yearly. Current period of empanelment of security gadgets and Rate Contract is valid till 30-06-2025.

As such, Bank invites NIT from all the empanelled vendors for empanelment of products and contract rates for one year i.e. w.e.f from 01-07-2025 till 30-06-2026. Empanelment will be done for the security products/gadgets categorized as under:

- i) Integrated Intrusion Detection Cum Fire Alarm System 8 Zone Micro Controller (expandable to 24 Zones) based Integrated IDS cum fire alarm with IP module
- ii) Cash Cabin Door Alarm (CCDA) including concealed lock type
- iii) Auto Dialers GSM and PSTN
- iv) **CCTV system** Network Video Recorders, Cameras (HD & IP), Hard Disk Drives and all other related accessories, etc.
- v) **Access Control System (ACS)** Face Recognition, Biometric, Proximity, Pin based multi-factor authentication Terminal, EM Locks and accessories
- vi) **Health Monitoring System (HMS) of Security Gadgets -** Empanelment of the Solution Providers and rate contact for devices, AMC and HMS charges

2. SCOPE OF THE WORK

System Integrators (SIs) which are on the empaneled list of Bank for the period 01-07-2023 to 30-06-2026 are invited to submit their proposal for empanelment of products, finalization of make & model and rates of all the products/ Gadgets and accessories. The empaneled products and their rates will remain valid for one year from 01-07-2025 till 30-06-2026. The specifications as also eligibility criteria for various products to be empaneled are same as mentioned in our above mentioned RFP dated 09-05-2023 read together with corrigendum published on Bank's website while empaneling the system Integrators and products except for IP cameras. Considering the implementation of CRO by Ministry of Electronics & Information Technology (MeitY) w.e.f. 09-04-2025 vide which BIS certification will be given only to STQC certified IP Cameras and the fact that the certification of IP cameras of various OEMs being at various stages resulting in nonavailability of the BIS certified products in the market for a few more months, SIs may also quote the existing models of IP cameras or equivalents not having BIS certifications but meeting the configuration as laid down in Appx-A, Para 5.B & C. Bank reserves the right to carry out fresh empanelment of BIS certified IP cameras after the same are available in the market from OEMs in compliance with the CRO. Once all the products/

gadgets and accessories are finalized by the Bank, financial proposals will be asked from the empaneled vendors only for the finalized products/ gadgets and accessories.

4. SUBMISSION OF APPLICATION

Tender Document as available on Bank's website, should be submitted duly filled and complete in all respect in a sealed envelope. In case an empaneled System Integrator fails to submit the tender or submits the tender late or submits the tender which is rejected for improper/incomplete submission, empanelment of the System Integrator will be terminated and no claim of the applicant will be acceptable. Further, the Bank reserves the right to accept or reject any or all proposals / tenders / products / pricing without assigning any reason.

- a) <u>Authorization from the OEM (MAF)</u>: Authorization from the OEM (MAF) as per Appx-B is required only for new OEMs being proposed/ quoted by the SIs. <u>MAF is</u> <u>not required to be attached for OEMs which are already empaneled with the bank.</u>
- b) <u>Technical Data sheet of the products</u>: Technical data sheets of only new products (New Make or New model of the existing Make) being quoted are required to be submitted.

The applicant must sign each page of their tender document and should submit duly filled & signed **Product Specification (Appendix-A)** along with technical data sheet of the products and Manufacturer Authorization Form (MAF), as required, failing which the proposal is liable to be rejected.

5. EVALUATION PROCESS

a) Technical Evaluation of NIT

The specifications as also eligibility criteria for various products to be empaneled are same as mentioned in our above mentioned RFP dated 09-05-2023 read together with corrigendum published on Bank's website. Incomplete tenders not accompanied by the mandatory documents shall be rejected. Offered products will be evaluated against the stipulated specifications, eligibility conditions and criteria based purely on valid proof of documents submitted by the applicant.

b. Display/Demonstration of Security Gadgets

Shortlisted applicants, after technical evaluation of their proposals to include proposed gadgets, **may** be asked to display the quoted products / gadgets, if being different than those presently empaneled, in our Office Complex on a scheduled date and time. Security gadgets which meet the specifications and eligibility criteria of the Bank shall be finalized for empanelment.

<u>c. Financial Proposals</u>

Financial Proposals will be invited from the empaneled vendors for the security gadgets approved & finalized after technical evaluation of the quoted gadgets / products.

d. Rate Rationalization

L-1 will be decided on the basis of lowest rate for each item, quoted by applicants in Financial Proposal. Thereafter, all shortlisted vendors may, at the discretion of the Bank, be called for a meeting, in which the rates for various items will be discussed & further rationalized/standardized on basis of lowest quoted rates. The rate for each product as finalized by the Bank shall be binding on all system integrators. If a system integrator is not inclined to accept the Bank finalized rates and opts out of the rate contract, their empanelment will be terminated.

6. ELIGIBILITY CRITERIA FOR EMPANELMENT OF PRODUCTS

For empanelment of a product, there is no change in specifications and eligibility criteria as mentioned in our RFP dated 09-05-2023. <u>System integrators are free to quote for new model of products as addition or change from the presently empaneled products subject to their meeting the laid down specifications and eligibility criteria.</u>

7. GENERAL INSTRUCTIONS/CONDITIONS

- a) Please read the terms and conditions carefully before filling the application form.
- b) The PROPOSAL should be submitted in a sealed envelope as under:
 - i) Printed, duly filled and Signed Hard Copy of ONLY the following to be submitted in a sealed envelope:
 - aa) Details of the security gadgets (Appendix-A)
 - ab) Authorization from the OEM (Appendix-B)
 - ii) All other supporting documents and Annexures to be submitted as scanned files in 'Adobe Acrobat Reader document (.pdf') format in a flash drive.
- c) There should be no cutting/over writings. The cuttings/over writings, if any should be duly attested by the authorized signatory.
- d) The Bank reserves all rights to:
 - i) Accept or reject the application either in whole or in part.
 - ii) Reject any or all the applications partially or wholly.
 - iii) Cancel or withdraw this tender.
 - iv) Accept or reject any deviation from these conditions.
