How to apply: The Tender should be submitted in separate sealed covers (Annx A with EMD in envelop1 and Annx B(Financial Bid only) in envelop no. 2, now both these envelop i.e no1 and no.2 should be kept in the third envelop which should be superscripted as “**TENDER FOR PURCHASE OF “Swift ZXI Car Model-2011)– MP-04-CH-3071”** addressed to the ZM. 5. OPENING OF TENDERS & VALIDITY PERIOD: The tenders received up to 03.00pm on **14-07-2025** will be opened at **4.00 PM on the same date by tender opening committee** at at Bank of India fourth floor. The tenderer himself/herself or one representative(With Authority Letter) of the bidders along with acceptable ID card like Aadhar card etc should remain present at the time of opening of tender bids. The tender proceedings will be finalized on the basis of Highest Bidding system. In case of dispute the decision of the tender opening committee will be final and binding. The offers will be valid for a

period of 07 days from the date of opening of bids to the Successful Bidder to enable the Bidder to complete all necessary formalities

6. During that period, the Successful Bidder has to pay the Full Amount of the Bid by demand draft/bank transfer drawn in favor of Bank Of India, payable at Bhopal.

7. The possession of the Car will be given to the Successful Bidder once the payment confirmation is obtained and RTO transfer process is complete.

8. All expenses with regard to transfer of ownership of the vehicle /RTO /Insurance expenses will have to be borne by the buyer only.
