Sub: Qualified institutions placement of equity shares of face value Rs. 10 each (the "Equity Share(s)") by Bank of India (the "Bank") (the "Issue") under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations").

Please note that the Capital Issue Committee ("**Committee**") has, at its meeting held today i.e. 11<sup>th</sup> December, 2023, approved the issue and allotment of 44,91,01,796 Equity Shares of face value Rs. 10 each to eligible Qualified Institutional Buyers at the issue price of Rs. 100.20 per Equity Share (including a premium of Rs. 90.20 per Equity Share) against the floor price of Rs. 105.42 per Equity Share, aggregating to Rs. 4,499,99,99,959.20 (Rupees Four Thousand Four Hundred Ninety Nine Crore Ninety Nine Lakhs Ninety Nine Thousand Nine Hundred Fifty Nine and Paise Twenty only), pursuant to the Issue in accordance with provisions of SEBI ICDR Regulations.

The Issue opened on 5<sup>th</sup> December, 2023 and closed on 8<sup>th</sup> December, 2023 and the same was intimated to you through our letters dated 5h December, 2023 and 8<sup>th</sup> December, 2023 respectively.

Further, find attached herewith the list of allottees – QIBs (grouped on common PAN basis) who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue, marked as **Annexure A**.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Bank stands increased from Rs. 4,103.57 crores, comprising of 410,35,66,070 Equity Shares to Rs. 4,552.67 crores, comprising of 455,26,67,866 Equity Shares.

The meeting of the Committee commenced at 11.00 AM and concluded at 11.30 AM.
