**Revision in Marginal Cost of Fund based Lending Rate (MCLR)  
Applicable from 01.08.2022.**

Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, this is to inform that Bank's Marginal Cost of Fund based Lending Rate (MCLR) has been changed to 7.60% w.e.f 01.08.2022 in terms of Pricing Policy approved by Bank's Board. ALCO in its meeting dated 29.07.2022 has approved the modification in Overnight, 1 month, 3 month, 6 month 1 year and 3 year MCLR by addition of 0.10% to existing rates.


