I have searched my old and found the attached letter regarding my holding of shares in Bank of India.

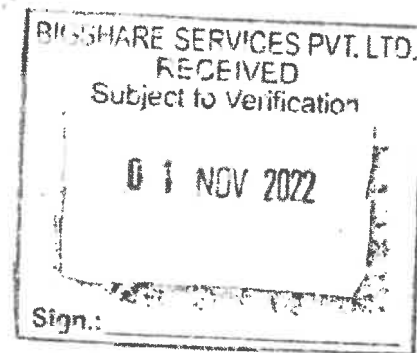

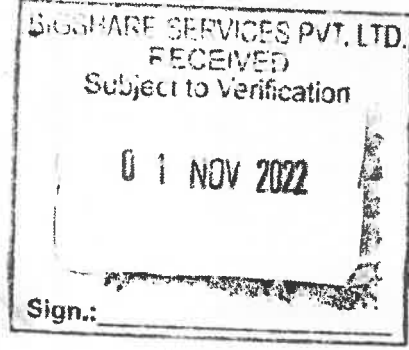
