- d) Sealed cover/s should be submitted by quoting rate/s for each vehicle;
- e) EMD shall be forfeited if the successful bidder fails to take delivery of the vehicle within 7 days from the date of intimation;
- f) Pay Order/Bank Draft of EMD of unsuccessful bidders shall be returned within one week of completion of procedure of sale;
