(a) The vehicle shall be sold on "as is where is basis"

(b) Earnest Money Deposit (EMD) of Rs. 20,000/- for the vehicle by the way of DD/Pay Order favoring "Bank of India" payable at Nashik to be sent along with the sealed offer.

- (c) Sealed and completed bids shall be dropped in the Tender Box placed at Zonal Office in closed cover super scribed "TENDER FOR VEHICLE FOR PURCHASE OF BANK'S OWNED MARUTI Swift ZXI BSIV", from 06-02-2024 to 12-02-2024 on working days from 10:30 a.m. to 05:00 p.m. No bids will be received after 05:00 p.m. on 12-02-2024 under any circumstances.
- (d) EMD shall be forfeited if the successful bidder fails to take the delivery of the vehicle within 7 days from the date of intimation.
- (e) Pay order/ Demand Draft of EMD of unsuccessful bidders shall be returned within one week of completion of procedure of sale. In case of the acceptance of the bid, the EMD shall be adjusted against the total price offered by the successful bidder. No interest shall be payable on the EMD.
- (f) The bids will be opened on 13.02.2024 (5:30 p.m.) at Zonal Office in the presence of the bidders who desire to be present at below mentioned address:

- (h) The bid to contain Xerox copy of valid address and ID proof of the bidder and the highest bidder should produce their original address and ID proof at the time of taking delivery of the vehicle for cross verification. The bid once made shall be irrevocable.
- (i) On payment of the total bid amount, documents relating to the vehicle shall be handed over to the successful bidder to enable him /her to get the vehicle transferred /registered in his / her name.
- (j) The successful bidder shall arrange to get the vehicle registered and lift/ take delivery of the vehicle after Name change in RC book and Insurance records within 7 days. The expenses for transfer will be borne by offerer.
- (k) The Bank shall have the option and liberty to sell the vehicle in case of the purchaser's failure to take delivery of the vehicle within the stipulated period after issuing a notice at the purchaser's given address. After a period of 15 days from issue of notice, the Bank shall be entitled to exercise its option to resell the vehicle.
- (l) However, the purchaser shall have no right or claim whatsoever, against the Bank after the period mentioned above on account of his failure to take delivery nor is the Bank bound to resell the vehicle or be answerable in any manner for any loss that he may incur on this account.
- (m) The Bank reserves the right to reject/accept any/all offer any bid without giving any reasons thereof.
- (n) Officers who are entitled for Bank's vehicle are not allowed to participate in the tender.
