### **TENDER PROCESS**

The auction process will be a sealed bid system. Interested Parties may submit their highest prices for each vehicle individually either for all or any one vehicle. The cover of the sealed tender document duly super-scribed as **BIDS FOR SALE OF OLD CARS** should be handed over / couriered / mailed to **Bank of India – Zonal Office (Chennai).** 

The sealed envelope MUST contain:

- The EMD of 10% of the Reserve price with a minimum of INR 12,500 (Rupees Twelve Thousand Five Hundred Only) for TN04 AF5244 vehicle and INR 9,000 (Rupees Nine Thousand only) for TN04 AA7575 infavor of Bank of India, payable at Chennai.
- (2) Undertaking / Declaration by the bidder in the prescribed format as detailed in the tender document.
- (3) All pages of tender document duly signed by the participating bidder(s).
- (4) Self-attested Photocopy of Proof of ID & Address
- (5) Quote / Bid in the prescribed format.

### TERMS AND CONDITIONS FOR SALE OF OLD CARS

1. The disposal of vehicle shall be strictly on "AS IS WHERE IS AND WHATEVER IS BASIS" and on "NO COMPLAINT BASIS" and no guarantee or certificate of its worthiness or quality will be given by the Bank. The condition of the vehicles can be inspected physically between 10 am to 4 pm on any working day between 22.02.2024 to 29.02.2024 at #30/17, STAR HOUSE, BANK OF INDIA – CHENNAI ZONAL OFFICE, PARRYS, CHENNAI – 600 001.

3. Bidders need to submit **Earnest Money which is 10% of the Reserve Price with a minimum of** of INR **12,500** /- (Rupees Twelve Thousand Five Hundred Only) for TN04 AF5244 vehicle and **INR 9,000** /- (Rupees Nine Thousand only) for TN04 AA7575. The earnest money can be deposited by Bank Draft / Banker's Cheque / Pay order in favor of **"Bank of India"** payable at Chennai. The Bank Draft / Banker's Cheque / Pay order should be attached with the quoted bid, failing which the bids will not be considered at all. If the highest Bidder / successful Bidder fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

4. EMD amount is payable by means of DD / Pay order / Banker's Cheque in favour of "Bank of India" payable at Chennai. Offers received without EMD amount shall not be considered at all by this Department.

5. The successful bidder will be required to deposit the total bid amount by means of DD/ Pay order/ Banker's Cheque in favour of **"Bank of India"** within **seven (7) working days** after receiving letter from the Bank in this regard.

6. EMD of the successful bidder(s) will be released only after realization of sale proceeds and transfer of ownership of vehicle. EMD of the bidders who fail to **honor** the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this department. EMD amount will not be adjusted in the sale amount accepted by Bank. EMD of successful bidder(s) shall be released only after successful completion of the sale process.

7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/ Voters identity Card/ Aadhar Card/ Passport in case of individual and Registration Certificate in case of firms etc.

8. The sold vehicle will be removed by the successful bidder(s) by depositing the money at their own expenses. No assistance/ transportation will be provided by the Bank. Permission to take out the disposed vehicles from Bank's premises will be allowed only on working days.
