- 1) Please refer to our Notice dated 06.03.2024 regarding above referred matter.
- 2) You are requested to submit your offer in enclosed quotation forms in two separate sealed covers. Please ensure to submit the same to our Office at Lucknow Zonal Office, Star House 1-Vibhuti Khand, Lucknow on or before 14-03-2024, **up to 05.00 p.m.**
- 3) While filling the tender/quotation forms, please ensure to follow below-mentioned instructions:
 - i) Lease period should be minimum 15 years.
 - ii) Increase in rent after 5 years, not more than 15%.
 - iii) No broker should apply.
 - iv) Only owner should apply in the tender, property shall be in his/her name.
 - v) Apply only in Bank's format. If bid submitted in another format, it will not be considered.
 - vi) All pages should be signed by the bidder.
 - vii) Conditional offer shall be rejected.
 - viii) Offer by Post shall not be considered.
 - ix) The offered building should have clear and marketable title free from encumbrance and permission to use for commercial purpose from competent authority.
 - x) Definition of Carpet Area: The carpet area would mean the usable carpet area based on net finished wall to wall measurements.
 - xi) Lease deed shall be executed in Bank's standard format.
 - xii) Property tax, Society Charges, Maintenance charges, Water charges etc shall be paid by the landlord only.
 - xiii) GST will be paid by the Bank.

- xxi) To arrange 3 phase electric connection with required power load on their own cost.
