SPECIAL INSTRUCTIONS TO TENDERERS

- (2) The tenders will remain valid for a period of 3 months from the date of openings of tenders. Bank reserves the right to accept or reject any orall the tenders without assigning any reason to do so. Bank does not bind itself for accepting the lowest tender.
- (3) The tenderer should quote the rates in figures as well as in words.
- (4) All erasures, corrections and alterations made while filling the tender must be attested by initials of tenderer. Overwriting of the figures is not permitted.
- (5) The Bank reserves the right to reject any or all the tenders, accept part of any tender or entrust the entire work to any contractor or divide the work to more than one contractor (item wise) without assigning any reason or giving any explanation. The rates quoted by the contract or will hold good for this bifurcation and no compensation will be paid on this account.
- (6) Joint tenders shall not be considered.
- (7) Within 7 days of receipt of Intimation regarding acceptance of histender by the Bank, the tenderer should send his acceptance of thework order in writing. If the tenderer does not do that, or does not startthe work within 10 days of such intimation to him or fails to give justifiedreasons not to do so, acceptance of his tender would be withdrawn and Earnest Money Deposit would be liable to be forfeited.
- (8) The rate quoted in the tender shall include all charges of scaffolding, lift, any tools and plants railway freight labour conditions and fluctuation the rates, excise duty, sales tax, octroi, works contract tax and any other taxes or expenditure for carrying out the work except GST.
- (9) Water and Electricity will be supplied free of cost at one point.
- (10) No Escalation in rates will be allowed under any circumstances.
- (11) The successful tenderer is bound to carry out entire work withinstipulated time limit. The tenderer will have to pay liquidated damagesfor non-completion of job within stipulated period @ 1% of the contracted amount per weekafter expiry of period of completion subject to maximum of 10 % of site contract value.
- (12) The liquidated damages as mentioned above may not be reformed if thecontractor applies sufficiently in advance for extension of timementioning the unavoidable reasons for extension. The Bank shall, if inits opinion (which shall be final and biding upon the contractor) findsgenuine reasons shown by the contractor for such request, grant suitable extension in time limit. Any claim for damage or compensationin relation there to by contractor is not permissible. Also other terms and conditions of the contract will remain unaltered in the extended period.

- (13) The successful tenderer is bound to carry out items of work necessary for completion of job even though the same are not included in the schedule of quantity. Rates of extra items will be derived from thetender. In case the rates do not exist in the tender and extra item is notsimilar to tender item, then the rates will be worked out on actual costof material and labour, any other expenditure for completing that workplus 15 % towards contractor's profit & overheads. For this contractormust submit the rate analysis supported by original vouchers forpurchase and labour.
- (14) The contractor must co-operate with other contractors appointed by thebank so that entire work shall proceed smoothly with least possibledelay and to the satisfaction of the Bank.
- (15) The contractor shall remove all rubbish etc. out of site/premises washand clean the floors and hand over the site in proper and tidy condition.
- (16) The tenderer shall acquaint him self with the site conditions making hisown arrangement for storing of material at site, lift, etc.
- (17) Contractor shall shift furniture, cupboard, records, for the purpose of electrification & wiring and rearrange the same as directed. No extracharge shall be paid for the same.
- (18) Contractor shall be prepared to work at times convenient to the Bank.No charges shall be paid for the same.
- (19) The contractor will attend to all defects noticed during defect liabilityperiod at his own cost. If the contractor fails to attend the defects within a reasonable time these defects will be rectified by the Bankand the expenditure incurred on this account will be recovered from security deposit, or any other money due on to time.
- (20) The contractor shall make adequate arrangement for watch and wardof his material and shall ensure the safety, breakage and any theft ofmaterial fixed or unfixed by him or other sub contractor.
- (21) The work executed should be got approved by the Consultant/Bankand contractor shall rectify any bad workmanship pointed out at anystages and remove from site all the rejected material immediately.
- (22) The contractor shall be responsible for application of labour laws, compensation for injury and accident to person, whether employed byhim or by his sub contractor. The contractor is supposed to obtain labourlicence from the Assistant Labour Commissioner under Contract Labour Actbefore commencement of the work.
- (23) The contractor will take necessary precautions for carrying out the workavoiding any damage to fixed or loose furniture, structures/decorativeparts of the property. The contractor will rectify any damages done athis cost.
- (24) The contractor shall ensure that workmen employed by him forexecution of work are suitably covered against workmen's Compensation Act, ESIS and other legislative enactments applicable to such works and workmen shall be to the contractor's account.
- (25) The contractor shall inform the Architect/Consultant/Bank to checkquality/ measurements of any work which is likely to be hidden beforecovering.

- (26) In case of non-completion or delay in completion of work or removal ofdefects in time, the Bank shall be free to appoint another agency to getthe job done at contractor's risk and cost.
- (27) Income Tax at applicable rate of the Bill Amount will be deducted atsources from the contractor's bill and will be deposited with the I.T.O.as per rules.
- (28) The Bank may delay the progress of work without, in any way, vitiating the contract and grant such extension of time for the commencement/completion of the contract as it may think proper and sufficient in consequence of such delay and the contractor shall not make claim for compensation or damage in relation there of.
- (29) The contractor will not execute any extra item without Bank'spermission in writing.
- (30) The quantities mentioned in the schedule of quantities areapproximate. Payment will be made on actual work done by the contractor. However, the contractor should not deviate the quantity without Bank's permission.
- (31) Conditional tenders quoted by the tenderer is liable to be rejected.
- (32) The Bank has a right to alter the nature of work and to add or omit anyitems of work or to have the option of the same carried outdepartmentally or otherwise and such alternations or variations shallbe carried out without prejudice to this contract.
- (33) The Bank has right to terminate the contract, if the contractor abandonsthe work, or fails to commence and complete the work in time, of fails to abide by the contract conditions.
- (34) Measurements for all items shall be taken as per actual work done and no claim for any wastage in all material shall be considered.
- (35) Contractor has to get the samples of all the materials like switch, wire, or any other accessories for the approval of the Consultant/Bank.
- (36) Contractor must quote balanced rates as quantities mentioned in thetender are approximate and may vary to any extent. No extra rate shallbe given on this account.
- (37) The contractor while executing the work during the working hours of the Bank shall take special care that disturbance is not created to Bank's staff and customer during the office hours. The contractorshould also keep the banking hall in a reasonably good condition during banking hours.
- (38) Contractor has to submit Photographs of the completed civil &furnishing work in duplicate along with soft copy in form of C. D.
- (39) During the execution of work, if any damage occurs to the property, structure etc. the same shall be made good by the contractor at hisown cost.
- (40) THE RATES SHOULD BE FIRM INCLUDING ALL TAXES EXCEPTGST. DISCOUNT IN TOTAL AMOUNT WILL NOT BE CONSIDEREDAND THE SAME TENDER WILL BE LIABLE FORDISQUALIFICATION.
- (41) The size of all the wooden members shown in this tender are NET/CLEARafter panelling.

- (42) All the Horizontal surface will have 1.5mm thick laminate & vertical surfacewill have 1.0mm thick laminate of approved make and shade.
- (43) All the wooden sections & plywood for partitions (or where necessary) willhave anti-termite paint from inner surface before laying the laminate.
- (44) While the work is in progress, if use of any sub standard material isobserved or in case of bad workmanship and if the Consultant instructsto dismantle and to redo the same the contractor shall do the same athis own cost and the Consultant's decision in this regard shall be final and binding.
- (45) The bidders are requested to visit the branch before quoting the rates. Submission of a tender by a tenderer implies that he has made himselfaware of the scope and specifications of the work to be done, siteconditions, and local conditions and other factors bearing on the execution of the work.
- (46) Jurisdiction:All matters arising out of or in any way connected with this agreementshall be deemed to have arisen at Durgapur& only the courts inDurgapur shall have jurisdiction to determine the same.
- (47) The contractor while executing the work during the working hours of BANK shall take special care that disturbance is not created to Bank's staff and customers during the office hours. The contractor should alsokeep the banking hall in a reasonably good condition during bankinghours.
- (48) The contractor is requested to obtain necessary labour licence from labour enforcing authority before commencement of the work. He is also required to abide by the labour laws applicable including submission of form VI B to the labour enforcement of ficer.
- (49) The contractors will adhere to the IBA/CVC guidelines during execution of works.
- (50) The rates will be valid for 90 days.
- (51) The contractor will prepared all the furnishing items at site only. The contractor will get the approval of sample of all the materials specified in the tender, such as plywood, laminate, paint, T W ect. From Bank/Architect. However, the contractor will have to produce invoice & certificate with the final bill from the respective company for the materials used at the above site.
- (52) Any extra items or excess quantity (other than tender) work are carriedout after approval from the competent authority only or else paymentwill not be made.

SPECIAL CONDITIONS OF CONTRACT

- 1. Earnest Money Deposit :Rs. 15,000/-
- 2. Initial Security Deposit (ISD): The EMD amount, of successful bidder.
- 3. Defects Liability Period: 12 months from the date of issue of virtual completion and handing overthe site to owners.
- 4. Period of commencement: 7 days from the date of Letter ofIntent/Work Order.
- 5. Stipulated period for completion: 30 days

- 6. Retention Money: 10 % of the final bill, (less the EMD / Initial Security Deposit).
- 7. Terms of Rate: The rates shall be at site of work and should be inclusive of all taxes including works contract tax, exceptGST.
- 8. Period of validity of Tender: Three months from the date of opening tender.
- 9. Period for honoring interimcertificate: 7 working days from the date of Consultant's certificate.
- 10. Period of honoring finalcertificate: 10 working days from date of Consultant's certificate.
- 11. Validity of rates after award of Tender: "NO ESCALATION IN PRICE WILLBE ALLOWED".
- 12. Release of Retention Money: 100 % shall be released aftersatisfactorily completion of DefectsLiability period of 12 months.
- 13. Payments: The contractor shall be paid by the Bank after completion of work only. No advance money will be given prior to the start of work. or dumping materials at site. When the work has been virtually completed and Bank's Architects / Engineer has certified in writing that the work has been completed on the basis of detailed measurements and has made a final scrutiny and that there is no dispute items, rates, ad quantities, the contractor shall be entitled to the payment of the final bill in accordance with the final certificate.

14. EARNEST MONEY AND SECURITY DESPOSITS :-

Bank is not liable to pay any interest on the Earnest Money. The Earnest Money of the unsuccessful Tenderers will be refunded without any interest soon after the decision to award the work is taken or after the expiry of the validity period of the Tender.

The successful Tenderer to whom the contract is awarded will have to deposit the EMD as "Initial Security Deposit" (ISD). Retention Money @ 10% of final bill shall also be deducted at the time of final bill payment, however the Total Security Deposit (EMD/Initial Security Deposit + Retentionamount) will be maximum 10% of the final contract value.

- 15. The Initial Security Deposit and Retention Money of the successful Tenderer may be forfeited if he fails to comply with any of the conditions of the contract. When the certificate of the virtual completion is issued to the contractor the security deposit in the form Security Money shall be refunded, provided that the contractor has fulfilled all the conditions of contract and further provided that the employer has no claim for forfeiture of part or whole of the said deposit. The retention money will be returned to the contractor after the expiry of defect liability period, subject to deductions for any appropriations thereof required to be made by the Bank as per conditions of the contract. The contractor is requested to sign each page of the quotation and put rubber stamp, seal below his signature and seal the quotation in an envelope.
- **16. Liquidated damages**: If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the contract period of completion, he shall without prejudice to any other right, pay as agreed compensation @ 1% of the contracted amount per weekas liquidated damages.

The tenderer should note that at the time of submission of the tender, associate family or firms (ownership/partnership/director with other familymembers viz.father/mother/sister/wife/son/daughter etc.) and firm having same Registered address is not allowed to participate, only one firm is eligible to apply for tender. In casemore applications are received from such firm/s, the Bank has a right to rejectboth the applications.

- 1. In consideration of the said contract amount to be paid at the time and in the manner set forth in the said conditions execute and complete the work shown upon the said drawings and described in the said specifications and the schedule of quantities, either in whole or in part.
- 2. The employer shall pay the contractor the said contract amount or suchother sum as shall become payable at the time and in the mannerhereinafter specified in the said conditions.
- 3. The term "the Consultants / Architects" in the said conditions shallmean the said ARCHON VISION, KOLKATA, Address- 57, MODEL TOWN GARIA, KOLKATA-84, BAKUL KUMAR BAG, MOB-9433110818, or in the event of their death or ceasing to be the consultants /architects for the purpose of this contract, such other person orpersons as shall being a nominated for the purpose by the employernot being a person to whom the contractor shall object for reasons(maintained in said conditions) considered to be sufficient by theemployer. Provided always that no person or persons subsequentlyappointed to be architects under this contract shall be entitleddisregard or over rule any previous decision or approval or directiongiven or expressed in writing by the architects for the time being.
- 4. The said conditions an appendix shall be read and construed asforming part of this agreement and the parties hereto shall respectivelyabide by to submit themselves to the conditions and perform therespective agreements on their part as contained in the said conditions contained.

toactual measured quantities at the rates contained in the schedule ofrates and probable quantities as provided in the said conditions.

- 8. The contractor shall afford every reasonable facility for the carrying outof the all works relating to Tender for Interior and Furnishing workfor MITHANI BRANCH, <u>At & Post Mithani, Dist Paschim Bardhaman West Bengal 713371</u>, for Bank of India,Bardhaman Zone. Preparing the furniture work and other ancillary works in the manner laid down in the said conditions, and shall makegood and damage done to walls, floors etc. after the completion of hiswork.

Theowner shall reserve the right to evaluate the samplewith regard to the specification before award of work. Samples as directed by the Consultant/Ownerfor various items shall be prepared/brought forapproval without any cost.
- 2. PLYWOOD: Plywood should be ISI make Termite and Powderproof.
- 3. GLASS: Glass shall be float glass of Modiguard company orapproved equal make.
- 4. TIMBER: Wherever specified shall be teak wood from CentralProvince (C.P.)/Ghana best quality.
