- b) Earnest Money Deposit (EMD) of Rs.5,000/- for each vehicle by way of DD/Pay Order favouring Bank of India payable at Ghaziabad to be sent along with the sealed offer;
- c) Sealed cover(s) should be submitted by quoting rate(s) for each vehicle as per Annexure-I (Financial Bid);
- d) If highest bidder does not accept the offer of sale of vehicle(s) for any reason whatsoever it may be and withdraws from the bidding, the Earnest Money Deposited by such bidder will be forfeited. In such case, the second highest bid amount may be considered for sale and accordingly the second highest bid amount will be considered as the highest bid amount, subject to minimum reserve price conditions.
- e) EMD shall be forfeited if the successful bidder fails to take delivery of the vehicle/s within 7 days from the date of intimation.
- f) Pay Order/Bank Draft of EMD of unsuccessful bidders shall be returned within one week of completion of procedure of sale;
