Offer/s in sealed envelope superscribed "**TENDER FOR VEHICLE/S**" alongwith an Earnest Money Deposit (EMD) of Rs.10,000/- for each vehicle by Demand Draft/Pay Order favouring Bank of India payable at Jaipur should reach to the Zonal Manager, Bank of India, GOD Department, Zonal Office, Jaipur Zone, Star House, B-4, Sector-2, Jawahar Nagar, Jaipur-302004 till **3.00 p.m. on or before 25.04.2024**.
3. The terms and conditions of sale are as follows:
 - a) The vehicle/s shall be sold on "**as is where is basis**".
 - b) Earnest Money Deposit (EMD) of Rs.10,000/- for each vehicle by way of DD/Pay Order favouring Bank of India payable at Jaipur to be sent alongwith the sealed offer.
 - c) Sealed cover/s should be submitted by quoting rate/s for each vehicle.



- d) EMD shall be forfeited if the successful bidder fails to take delivery of the vehicle/s within 7 days from the date of intimation.
- e) Pay Order/Bank Draft of EMD of unsuccessful bidders shall be returned within one week of completion of procedure of sale.
